A regular meeting of the Board of Directors of Northeast Louisiana Power Cooperative, Inc. was held at 1411 Landis Street, Winnsboro, Louisiana at 9:00 a.m. on Tuesday, March 28, 2023.

Directors present were Weldon Fitch, Thad H. Waters, Jr., Davin McMurry, Charles Hixon, Alton L. Welch, Jr., Richard Strong and Ronald Pippin. Others present were Jeff Churchwell, General Manager, James Berry, Attorney and Nora Pylant, Accountant.

Mr. Fitch called the meeting to order. Mr. Churchwell led the invocation and the Pledge of Allegiance to the American flag.

Mrs. Pylant read the minutes of the February 28, 2023, meeting; the minutes were approved as read. Mrs. Pylant read the minutes of the March 14, 2023, special meeting; the minutes were approved as read. Mr. Churchwell reported no accidents for the month of February.

Mr. Churchwell reported that Mr. Veneeth Iyengar visited on March 24 representing the Connect LA office, interviewed Volt subscribers in the GUMBO area.
